Shared Branching IDs

Starting May 1st, 2025, all shared branching customers with out of state identification will have to verify their identity using the following steps:

- With your phone, go to verify.coop.org or scan the QR code located within our branch
- Follow the instructions that pop up on your phone screen
- Once you have your 6-digit code, proceed to your next available teller to complete your transaction.

New to our app as of April 24th, 2025, we now offer institution to institution transfers! With just a \$0.50 fee for standard transfers (2-3 business days) or \$3.00 for next day transfers, you can get your money where you need it on your time.
